Re: Follow up on the 23rd February General Stakeholder meeting on the Code of Conduct, concerns regarding governance and content

Dear Ms Chaze, Dear Ms Nikolakopoulou, Dear Mr Soro,

With our joint letter of 16 February 2021 (see attachment), we shared with you our full support for the EU Green Deal ambitions of the European Commission and our first assessment of the code of conduct initiative, both from a governance and a content perspective.

It is only to a very limited extent that the 23 February 2021 plenary meeting addressed the points raised in our 16 February letter.

1) Governance

The Code of Conduct initiative is to be finalized by June 2021. This is an extremely ambitious timeframe, especially for an initiative that has 'the potential to put food production on the good track', as stated by an EU Commission representative.

The questions raised during the General Stakeholder meeting on 23 February 2021 regarding the number of meetings scheduled and their rhythm and the composition of the task forces were not clearly answered – and this just days before the work on this initiative is supposed to start.

Questions on the internal processes, such as the selection of the task forces Chairs and Rapporteurs or the participation or not of private companies were not clearly answered including in the roadmap sent after. A good, exemplary governance for the Code of Conduct initiative of the European Commission is a pre-requisite for its overall success. Even in the light of the extreme time pressure imposed by the EU Commission top hierarchy, compromising governance for speed is generally ill-advised.

2) Content of the code

As pointed out in our 16 February 2021 letter, the 'potential aspirational objectives' of the Code are to be proposed and supported by the 'middle of the chain actors' (food processors, food services and retailers as we understood it), but these aspirations will have consequences at all levels of the EU agri-food chain. Such a linear conception of the food chain is inconsistent with the model of circularity that is promoted by the EU Commission as a major driver of more sustainable food systems.

The ambitions formulated by food processors and retailers will ultimately become the responsibilities of the primary producers, who are not even considered as the main focus of this initiative. Therefore, we would like to reiterate our request for the following fundamental principles to be at the heart of the Code drafting and endorsement procedure:

- 1. The actors or any signatory cannot make commitments that imply or impact other members of the food supply chain without their consent.
- 2. In case commitments impacting several actors are taken, the added value and cost they entail should be fairly shared among the actors involved.
- 3. We would like to reiterate that the aim is that all food sectors improve their sustainability. Wording that opposes sectors/steps in the chain must be avoided.

The respect of these basic principles is a prerequisite to allow the sectors we represent to fully engage in this. We believe that this constitutes the basis for a fruitful initiative that will support further EU agri-food sustainability, to which we are looking forward to contribute.
